3.0 BUILDING PERMITS:

- 3.1 Michelle Dubois Tm. # 25-109 requesting a Land Use Compliance Permit to construct a 12 X 14' storage shed. Kendall moved to deny the construction due to setbacks and forward it to the Zoning Board of Adjustment for consideration. Florence second all voted in favor.
- 3.2 Scott Chausee Tm. # 22-59 requesting a Land Use Compliance Permit to add a 21 X 15' addition to existing outbuilding. Tabled for inspection
- 3.3 David Barkie Tm. # 11-27-3 requesting a Land Use Compliance Permit for the previously constructed 6 X 12' wood shed attached to the existing garage. Florence moved to approve the building permit, Revane second all voted in favor. Permit # 24-19.
- 3.4 Jonathan Stuart Tm. # 14-249 requesting a Land Use Compliance Permit to construct a 30 X 30' garage. The select board inspected and found that the setbacks complied with the Land Use Ordinance. Revane moved to approve the building permit, and Florence second all voted in favor. Permit # 24-20
- 3.5 Charles Webber Tm. # 14-114 requesting a Land Use Compliance Permit to construct a 28 X 32' detached garage. The select board inspected and found that the setbacks complied with the Land Use Ordinance. Florence moved to approve the building permit, Kendall second all voted in favor. Permit # 24-21
- 3.6 Select board inspected 128 Madison for Compliance Certificate. The select board inspected and notified the property owner of the deficiency and will reschedule the inspection.
- 3.7 Jacob and Iris Jaffe Tm. # 12-104 requesting a Land Use Compliance Permit to enclose a pre-existing deck as a mudroom (14'4" X 9' 3"). Construction of spa deck on the side of the house (13 X 13'). Extension of the existing second-floor deck (18 X 2'8"). Construction of stone chimney and fireplace (3 X 6'). Construction of a patio (10' diameter circle). Construction of walkway (4 X 48'). Florence moved to deny the building permit due to a sideline setback. Revane moved to deny the permit due to setbacks and impervious coverage. Kendall second all voted in favor. Forward to Zoning Board of Adjustment for consideration.
