DID YOU KNOW!!

The Planning Board wants you to know that the new Noise Ordinance, to be voted on at Town Meeting this year, is an amendment to the existing Noise Ordinance.

We worked on this amendment with the Police Chief to create an ordinance that is complaint-based. No one will be cited for a noise violation unless there is a legitimate complaint lodged by someone who is disturbed by the noise levels caused by another person. No complaint = no violation. It is written to protect you and our community from nuisance noises at night.

Please consider your neighbors and their circumstances, along with the level of noise you will be making, in order to help us keep the peace between 10 PM and 7 AM.

The Planning Board recommends this amended noise ordinance.

**The Town of Washington Ordains:
Ordinance #93:011
Spring Road Load Limit Posting**

Limitation of Use: Except as specifically provided in Section V below, it shall be unlawful for any person to operate any motor vehicle weighing more than six (6) tons on any Limited Weight Street, Highway from **March 1st to May 31st** or as deemed necessary.

Special Permits: The Road Agent shall issue a special permit after consulting with the Board of Selectmen for the operation of vehicles weighing more than six (6) tons over Limited Weight Streets, Highways and/or Bridges only after the Road Agent and Selectmen determines that the vehicle will not cause unusual damage to the highway.

Exceptions: Delivery vehicles making occasional trips to service residences. Any permitted business in the Town of Washington operating a Motor Vehicle empty over six (6) tons from their place of business to and from N.H. Route 31 and N.H. Route 10.
